This training course will give practitioners with experience in patents an in-depth understanding of German and European patent law with particular emphasis on patent prosecution, opposition and litigation.

Lectures and workshops, including working on hypothetical cases, will generally be held from 9:30 a.m. to 12:30 p.m. and 2:00 p.m. to 5:00 p.m. from Monday to Friday. The course will begin with a reception on Sunday, 16th September 2018.

The lectures will be held in English. Additionally, we are pleased to be able to offer various guest lectures e.g. by members of the European Patent Office.

There will be a trip to Neuschwanstein castle and Linderhof castle, a visit to the famous Munich Oktoberfest, and optional visits to sports or cultural events.

The total fee for the course, which includes all lecture materials, daily lunch and costs for all social events, is EUR 2500,- (excl. VAT) for two weeks, and EUR 1250,- (excl. VAT) for one week.

Due to the limited number of participants which can be accommodated, those who wish to attend should register online or contact our office as soon as possible. Participants will be admitted on a first-come, first-served basis. Our office will be glad to assist with hotel accommodation. Details will be provided upon request.
